## **Sliding Scale Fee Program**



GPS Psychology & Anxiety Clinic is committed to providing accessible and affordable mental health care. Our sliding scale fee program offers a reduced rate for behavioral health therapy services, covering 4-6 sessions. Ongoing services will be re-evaluated on a case-by-case basis.

Our therapy approach is rooted in evidence-based practices, ensuring precise diagnosing and careful treatment planning. For conditions like OCD, our sessions focus on integrating Cognitive Behavioral Therapy (CBT) with Exposure and Response Prevention (ERP). We empower our patients to become experts in identifying factors maintaining their symptoms and applying evidence-based interventions.

Based on the 2024 Poverty Guidelines, the following sliding scale fees apply:

- **100% Poverty Level** Initial Consultation: \$30 Follow-up Sessions: \$15 each (for 4-6 sessions)
- 200% Poverty Level Initial Consultation: \$75 Follow-up Sessions: \$37.50 each (for 4-6 sessions)
- **300% Poverty Level** Initial Consultation: \$120 Follow-up Sessions: \$60 each (for 4-6 sessions)



Ongoing services beyond the initial 4-6 sessions will be re-evaluated on a case-by-case basis, taking into consideration the patient's continued financial situation and therapeutic needs.
